DEPARTMENT MISSION

The University of Wisconsin-Madison, Division of Extension is a unique partnership of counties, the U.S. Department of Agriculture, and Extension working together to help people apply research-based information to benefit people's lives, businesses, and community resiliency.

For over a century, Extension has come to represent the Wisconsin Idea – expanding university knowledge to every person in the state. As a Division of the University of Wisconsin-Madison, Extension expands the University's outreach. Extension epitomizes the Wisconsin Idea, delivering programming across the state to create solutions. Extension also partners with business and government leaders, community groups, agriculture, natural resources, and youth and family development professionals to collaborate on research opportunities.

Extension works alongside the people of Wisconsin and in partnership with Eau Claire County to deliver practical educational programs—on the farm, in schools, and throughout urban and rural communities. Extension has a measurable impact – changing lives and communities through:

Supporting Wisconsin's Agriculture Industry »

Whether on the farm or in the field, we are on the front lines of modern agriculture, building stronger, more productive food systems and agricultural products. From animal management to crops and soils to financial planning, our educators and researchers help solve challenges that Wisconsin producers face.

Empowering Families and Communities »

We provide individuals and families with the tools and guidance they need to adopt positive health behaviors. Our programming focuses on nutrition, food security, food safety, chronic disease prevention, mental health, substance abuse and health insurance literacy.

Promoting aging-friendly communities »

We embrace the philosophy that each stage of life is unique, exciting, and filled with potential. Our programs promote aging-friendly communities, coach parents and help families put technology, mindfulness, and financial awareness into everyday use.

Supporting Positive Youth Development »

Our research-based youth enrichment programs give young people the hands-on experiences they need to grow into the global leaders of tomorrow. From youth governance to Wisconsin 4-H clubs, we provide diverse educational opportunities to prepare youth for success in Wisconsin and beyond.

Right here in Eau Claire County, Extension enhances the lives of families and communities in both rural and urban locations. The following are examples in the past couple of years where you see the Extension Department mission of bringing university knowledge and research to the local community in action: Farm Technology Days, Breakfast in the Valley, Family Resource Center, United Way, Eau Claire City-County Health Department, L.E. Phillips Memorial Library, Eau Claire Community Foundation (leveraging grant money that spans beyond tax levy allocations), Family Literacy, Child Care Partnerships, programming in schools with over 50% free and reduced lunch participation, and leadership in the Market Match program at the Farmer's Market – multiplying purchasing power for families who are income-eligible and strengthening the local food economy by increasing revenue for small-scale farmers. We teach with clientele at locations such as: Western Dairyland, Fresh Start, Beacon House, Boys and Girls Club, the Affinity House, Juvenile Detention: 180 Day Program, and the Eau Claire Hmong Mutual Assistance Association. We partners in extensive coalition work, such as: Hunger Prevention Coalition, Health Communities-

Chronic Disease Prevention Action Team, Healthy Retail Collaboration, Breakfast in the Valley, Chippewa Valley Technical College, farm service agency, Wisconsin Department of Natural Resources, Eau Claire County Land and Water Conservation Department, plus working in locations around the county including: Brunswick, Pleasant Valley, Town of Union, Fall Creek, Augusta, Osseo, Bridge Creek, Altoona, and many locations in the city of Eau Claire, plus local agriculture radio interviews to share latest research and best practices for emerging topics and trends, and more. These examples are not exhaustive.

VALUE TO EAU CLAIRE COUNTY

- Access to world-class research and faculty to partner in addressing real-world problems.
- Local county educators who understand the needs of local communities while connected to statewide resources.
- Participate in applied research projects and access to cutting-edge approaches in emerging issues.
- Enhance the quality of families' lives.
- Provide leadership and opportunities for youth to lead healthy productive and engaged lives, leading to lifelong skills needed to become competent adults.
- Through the county's partnership with Extension, the federally funded nutrition education program, FoodWise is provided to residents across Eau Claire County, with approximately \$132,162 federal funds secured and allocated in Eau Claire County.
- Cost-sharing of 2 positions: Community Development Educator and Horticulture Program Educator (with Chippewa and Dunn Counties).
- UW-Madison Extension co-funds all educator positions on the 136 Contract in Eau Claire County. The county is charged a flat fee for each educator, equaling roughly half of the actual cost. Further, with the robust Extension partnership, county levy dollars have historically been multiplied \$3-\$5 for every \$1 county levy dollar invested, which includes the co-funded positions as well as an expansive volunteer network (working with youth, horticulture, and agriculture), donations, grants, and equipment.

DEPARTMENT BUDGET HIGHLIGHTS

Extension-Eau Claire County provides critical services to Eau Claire County. Extension is uniquely positioned to solve social and community issues by delivering high-quality educational programming targeted to outcomes that will benefit everyone. The department makes agricultural connections across the county to improve food systems, addressing food issues and bringing food produced in the county to others in need. The department's resources educate local agriculture producers and develop local markets for agricultural products, supporting the agriculture economy and generating economic development and growth in the county. The department offers programming and services which support youth, families, and community development. The offerings reflect the needs of residents across Eau Claire County, in direct response from its communities. Budget constraints over the past few years have put a strain on staff's ability to adequately meet the needs of the community, thus we are seeking increased financial support to maximize programming impact.

STRATEGIC DIRECTION AND PRIORITY ISSUES

Strategic Direction

Extension Eau Claire County provides critical services to Eau Claire County. From supporting local food systems to meeting the needs of families, Extension is uniquely positioned to solve social and community issues and deliver high-quality educational programming.

Priority Issues

A new Area Extension Director will be hired for Area 6 (Eau Claire, Chippewa, Dunn) late summer of 2022. Priority issues and programming initiatives will be determined for 2023 once the new AED has had the opportunity to look at the county strategic plan as well as Educator plans of work.

TRENDS AND ISSUES ON THE HORIZON

- ***Making agricultural connections across the county to improve food systems***
Extension educators and coordinators are making crucial connections across Eau Claire County and will enhance those efforts in the year to come. Through their work with farmers and families, educators are bringing food produced in the county to others in need. Eau Claire County ranks higher than state averages for food insecurity and access to healthy foods, and educators are making connections with small-scale farmers interested in developing profitable and healthy community-based food systems to address food issues.
- ***Supporting youth, families, and community development***
Extension educators and coordinators deliver programs to help county residents, including targeting food insecurity and farm transfers as well as assistance to youth and families. Extension leverages a comprehensive, coordinated system of services that will meet the needs of children, youth, and families, including underserved populations. Extension is a major partner with the Family Resource Center's Triple P (Positive Parenting Program).
- ***Generating economic development and growth***
Extension educators are focused on providing the research and practical resources to support local farmers with dairy and livestock production/management and related crop production. These partnerships foster networks and develop local markets for agricultural products and the agriculture economy.
- ***Programming that is responsive to community needs***
Extension educators deliver human development, 4-H, community development, agriculture, horticulture, and food programming that reflects the needs of residents across Eau Claire County, in direct response from its communities. Through programming and reach across cities, villages, and towns in Eau Claire County, Extension delivers relevant educational resources targeted to outcomes that will benefit everyone.

POSITION CHANGES IN 2023

- None foreseen.

OPERATIONAL CHANGES – WITH FISCAL IMPACT

- The budget also reflects funds to reinstate a 4-H summer intern to assist in the many activities, camps, and program opportunities that 4-H offers. This position will be an addition to the 136 contract and an increase of approximately \$6,500.

OPERATIONAL CHANGES – WITHOUT FISCAL IMPACT

- None foreseen.

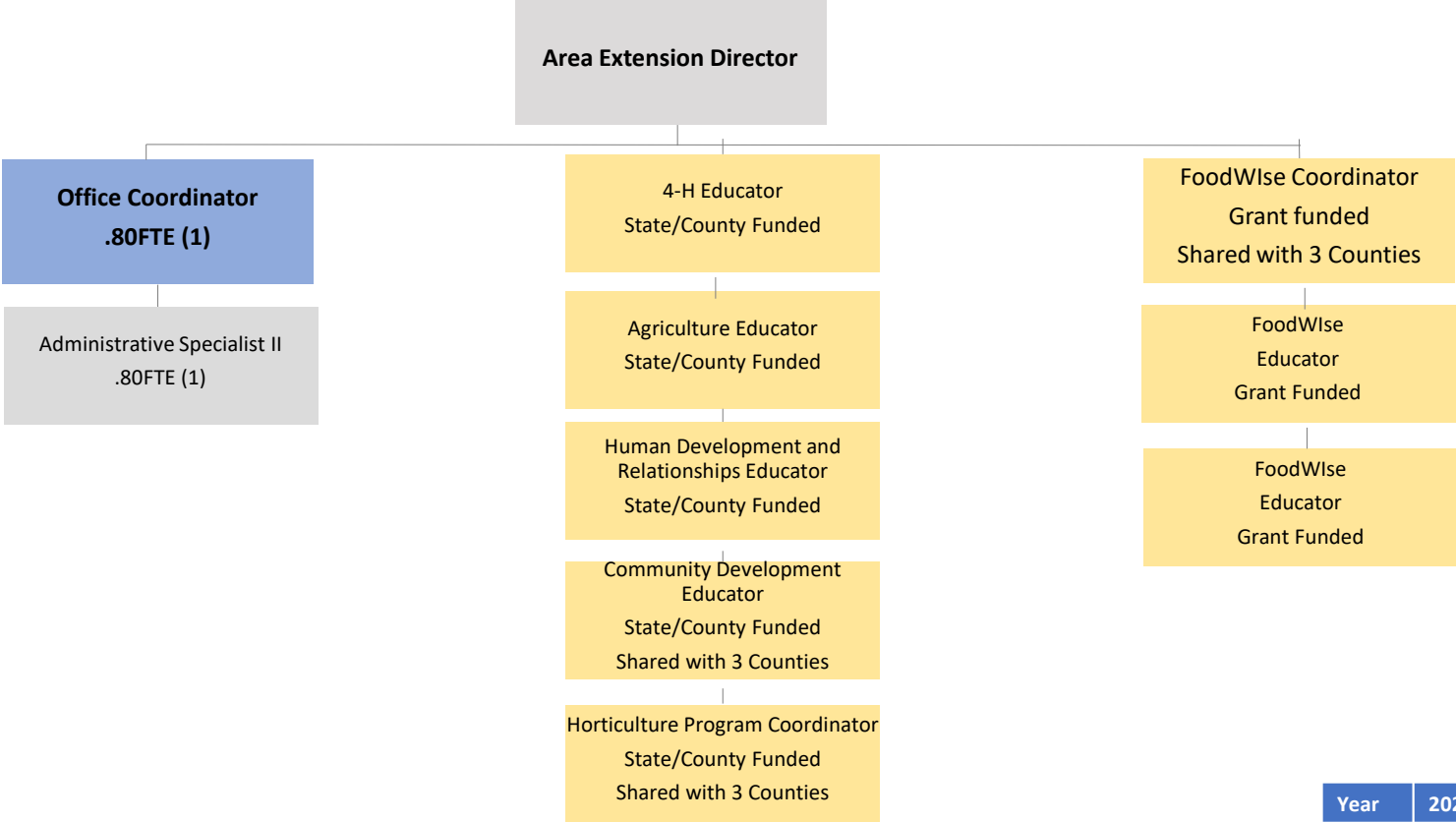
KEY ASSUMPTIONS AND POTENTIAL RISKS

Over the years, the Eau Claire County Extension office has not asked for increases and has, instead, absorbed multiple increases including laptop/computer replacements, health insurance increases, salary increases, and increases to the contracted educational services line. The Extension department will continue to partner with the state and cost-share educator positions, leverage external funding, and seek external grants when possible. This budget reflects a \$10,000 increase in supplies, travel, and professional development line items, to assist educators in delivering needed education to the Eau Claire community.

However, if the requested levy increase is not approved, Extension may need to consider reductions in services and/or staffing to meet the increased cost of personnel and the 3% increase in the contractual services co-funded positions.

For 2023, the University of Wisconsin-Madison, Division of Extension is building a 3% fee adjustment for co-funded positions to address added costs of doing business. In Eau Claire County the increase is from \$43,600 to \$44,900 per 1.0 FTE. The contracted services related to fees for employee Extension educators in Eau Claire County increased by \$4,667. This 3% increase is expected to occur in 2024 as well; the hope is that small consistent increases will help counties better prepare their budgets in advance. The \$10,000 discount remains in place for 2023.

The fair partners with University of Wisconsin Madison, Division of Extension, Eau Claire County (including, but not limited to, the Eau Claire County 4-H program), FFA, and any other approved youth organization. The Committee is a working committee included within the structure and under the guidance of the Eau Claire County Extension Education Committee (hereinafter "Extension Committee").

BY-LAWS:

A. MEMBERSHIP OF THE COMMITTEE:

The Committee will consist of Two (2) non-voting members and Eleven (11) voting members created from the following:

1. The 4-H Program Educator as a non-voting member.
2. The Fair Coordinator as appointed by the Friends of the Fair, as a non-voting member.
3. One (1) member who is either an FFA or agricultural teacher (active or retired); a FFA Alumni; or a member of a livestock group such as Wisconsin Simmental Association or Wisconsin Pork Producers.
4. Three (3) youth members, of which one must represent exhibits other than livestock, i.e., photography, arts & crafts, etc.
5. One (1) member of the Eau Claire County Board of Supervisors, serving on the Extension Committee, to be appointed by the Extension Committee.
6. Two (2) members who are employed by a business or a representative of a youth service agency or organization that provides services to youth such as the Boys & Girls Club, YMCA, Boy Scouts, Girl Scouts, etc.
7. Two (2) members who are citizens at large and who have an interest in the fair.
8. One (1) member who is a member of the Friends of the Fair, other than the Fair Coordinator.
9. One (1) member who is a member of the 4-H Leaders Association.

B. TERMS OF MEMBERS:

1. Members, other than youth members, will be appointed for a two-year staggered term. Terms will begin on September 1 and end on August 31. Five of the members will begin their terms in even years, and the remaining six will begin their terms in odd years. If and when vacancies occur the person appointed to fill the term of the departing member will fill out the term of the member who left and then will need to be re-appointed consistent with the staggered term of the member who left the committee.

2. Youth members will be a minimum of 14 years of age when appointed serving one (1) year terms. Youth members may reapply for appointment up to and including the year they turn 21.
3. All members of the Committee except for the County Board member will be confirmed by the Extension Committee. Nominations for the year will open on May 1 of each year and need to be submitted no later than July 31. The Fair Committee will meet in August to discuss applications and make recommendations for the appointments. The Fair Committee Chair will provide appointment recommendations to the Extension Committee Chair. Appointments will be confirmed at the August Extension Committee meeting so that those who are confirmed are able to begin their term on September 1.

C. **MEETINGS:**

1. The Committee will hold a minimum of one (1) meeting per month.
2. The meetings will comply with the Wisconsin Open Meetings Law and will post notice of the date, time, place, and agenda of the meeting on the Eau Claire County website.
3. Meetings will be conducted according to Roberts Rules of Order and follow the published agenda.
4. The Chair of the Committee will be a voting member.
5. The Committee will determine the date, time, and location of the following month's meeting as an agenda item for the current meeting.
6. Committee members are encouraged to attend all meetings. If a member misses more than three (3) meetings during a calendar year the Committee may take action to remove the member from the Committee.
7. Annually, after the conclusion of the annual fair and during the September meeting, the Committee as part of its agenda will elect a Chair and a recording Clerk from its members. The function of the Chair will be to establish the agenda for the meeting, and to conduct the meetings according to Roberts Rules of Order and consistent with the published agenda. The recording Clerk will take the minutes from the meeting, record the results of votes on motions, type the minutes and provide them to the county for posting on the county website and inclusion with the member meeting packets provided prior to meetings. Copies of the approved minutes will be made public record on the Eau Claire County Website and stored at the offices of the Fair Coordinator.

D. **REPORTING:**

The Committee will designate a member to at least one time per month report the activities of the Fair Committee to the Extension Committee. The report can either be in person or by written report. The Extension Committee can change the frequency of the reporting.

E. AMENDMENTS:

These by-laws may be amended by a majority vote of the total members of the Committee. Prior to taking the vote the moving member must provide a written copy of the proposed amendment to all the members of the Committee and the matter must have been placed on the agenda for consideration at a properly noticed meeting.

Once approved by the Fair Committee, the Fair Committee Chair will forward the proposed changes to the Chair of the Extension Committee for review and final approval by the Extension Committee.

F. FRIENDS OF THE FAIR:

The committee member representing the Friends of the Fair on the Fair Committee is the liaison for the financial support of the Fair. The Friends of the Fair helps secure the resources needed to provide the financial stability that will assure the future of the Eau Claire County Fair as a family and youth focused event.
