This resolution creates a special committee, known as the Eau Claire County Opioid Settlement Task Force, for the purpose of developing an objective process for distributing and expending the Opioid Settlement funds in compliance with the required guidelines and criteria.

The Opioid Task Force will be tasked with recommending uses of the settlement funds to be used for opioid abatement purposes such as expanding addiction treatment, increasing adoption of clinical best practices.

The Opioid Task Force shall consist of 10 members appointed by the County Board Chair, and confirmed by the County Board, who shall be chosen as follows: Three (3) members from the Eau Claire County Board, One (1) member representing public health, One (1) member from the Sheriff's department, One (1) member from the City of Eau Claire Police Department, One (1) member from the Department of Human Services, the Criminal Justice Services Director, and Two (2) Citizen members – One (1) who has or is working in opioid abatement, and One (1) who has had lived experience.

AUTHORIZING THE CREATION AND ESTABLISHMENT OF AN EAU CLAIRE COUNTY OPIOID TASK FORCE

WHEREAS, Eau Claire County is scheduled to receive an Opioid settlement of approximately \$2.5 million dollars, or approximately \$137,000 each year, for 18 years to be used for opioid abatement purposes; and

WHEREAS, pursuant to the settlement agreement, the opioid settlement funds are to be used for opioid abatement purposes such as expanding addiction treatment workforce, increasing adoption of clinical best practices, and improving enforcement of mental health parity and consumer protection laws at the state level; and

WHEREAS, the county board finds it appropriate to create an Eau Claire County Opioid Task Force to ensure the expenditure of the Opioid Settlement funds complies with the required guidelines and criteria; and

WHEREAS, task force members will consist of Eau Claire County Board members, Eau Claire County staff and citizens with a community wide view who are otherwise not acting on behalf of their own organization /project.

THEREFORE, BE IT RESOLVED, the Eau Claire County Board of Supervisors hereby creates a special committee, known as the Eau Claire County Opioid Settlement Task Force, for the purpose of developing an objective process for distributing and expending the Opioid Settlement funds in compliance with the required guidelines and criteria; and

 BE IT FURTHER RESOLVED, the Opioid Task Force will be tasked with recommending uses of the settlement funds for community assessment and opioid abatement purposes such as: enhancing addiction treatment; Evaluating and implementing community based prevention; and increasing adoption of best practices, and

BE IT FURTHER RESOLVED, the Opioid Task Force shall consist of 10 members appointed by the County Board Chair, and confirmed by the County Board, who shall be chosen as follows: Three (3) members from the Eau Claire County Board, One (1) member representing public health, One (1) member from the Sheriff's department, One (1) member from the City of Eau Claire Police Department, One (1) member from the Department of Human Services, the Criminal Justice Services Director, and Two (2) Citizen members – One (1) who has or is working in opioid abatement, and One (1) who has had lived experience.

Criminal Trial Backlog Prosecutors	\$ 775,859	4.1 Public Sector Employees	Due to COVID-19, a significant backlog for criminal jury trial cases was created by the suspension of in-person court proceedings. This request is to create two full-time Assistant District Attorney positions for a limited term of three years to assist in clearing the existing backlog that will create a state of crisis for years to come if not rectified. On average, there are 31 jury trial cases each year in Eau Claire County. Due to the pandemic, there were 26 untried cases in 2020 which were cared forward to 2021, increasing the total expected cases to be tried in 2021 to 57. 17 jury trials were held in 2021, which moved 40 untried cases to 2022.
Fairchild Senior Living	\$ 231,201	2.15 Long Term Housing Security Affordable Housing	Project includes work needed at our Fairchild Senior Living Facility to prevent cancellation of property insurance, meaning continued affordable housing to eleven existing households, PLUS completion of vacant wing into three additional two-bedroom, handicapped accessible units. Our insurance carrier requires we complete work on grounds (parking lot replacement and cement work at curbs/sidewalks surrounding the building). Without funds to do this work, we will lose insurance threatening continue housing for eleven existing units. We propose to also complete the vacant wing which will house three additional households.

Meals on Wheels Equipment	\$ 9,950	1.10 Covid 19 Aid to Impacted Industries	During the course of the COVID-19 Pandemic Meals on Wheels for Eau Claire County has seen a significant increase in demand for meals delivered to homebound individuals. There was a 33% increase in home delivered meals served from 2019 to 2020 and 11% from 2020 to 2021. By having such an increase in meals, it has required more equipment to ensure food is kept safe and delivered at proper temperatures. By purchasing additional equipment we would be able to replace worn out bags and coolers as well as provide additional support to maintain heat and cold for the food.
Laboratory Capacity Expansion (ICP-MS)	\$ 155,000	5.15 Drinking Water other Water Infrastructure	ECCCHD is requesting funds through the Eau Claire County allocation of the American Rescue Plan Act (ARPA) of 2021 to purchase and install a new analytical instrument (ICP-MS) to enhance laboratory analysis for select metals at the ECCCHD laboratory. ARPA funding provides a unique opportunity to fund an initial investment in laboratory infrastructure that may otherwise be difficult to make due to the significant start-up costs associated with this instrumentation. The addition of an ICP-MS and associated laboratory certifications would make it more cost-effective and convenient for private well owners and municipal partners to test for metals and eliminate some of the current concerns identified by other potential clients such as time and cost of testing for multiple contaminants. This proposed expenditure is consistent with the named eligible uses for ARPA funds (see page 3 of SLFRP-Fact-Sheet-FINAL1-508A.pdf), as this purchase would be an investment in water testing infrastructure that seeks to enhance the understanding of drinking water
Technology Enhancement: Module Additions to the Avatar System	\$ 140,000	1.12 Mental Health Services	The Avatar Electronic Health Record System serves as Human Services electronic health record and case management for mental health substance misuse services. Human Services has the responsibility to respond to mental health and substance use disorder service needs. Mental Health and substance use disorder is identified as one of the Community Health Priorities for Eau Claire County. In addition, COVID has led to an increase of mental health and substance use disorder issues. This project would enhance program and fiscal management of the mental health and substance use disorder services. The project adds the modules to the Avatar System increasing efficiencies to the management, operations, and reporting.

Water Quality Testing in Eau Claire Countys Private Wells	\$ 97,933	5.16 Water and Sewer Private Wells	The goals of this proposal are (1) to establish a better understanding of groundwater quality in Eau Claire County through systematic private well testing, (2) to identify areas of concern associated with consistently elevated contaminant concentrations, and (3) to inform decision-making pertaining to ordinances and regulations protecting drinking water at the county level.
Early Intervention Services for families who enter the Child Welfare or Youth Justice System to prevent Out-of-Home Placement	\$ 150,000		This early intervention project provides a response to families of what they may need to maintain their basic needs of housing, and the care and support to their children and youth, to prevent an out-of-home placement. This service prevents and reduces the number of youth and children removed from their homes and families. This project responds to needs, unable to be covered by other
Meals on Wheels LTE Staffing	\$ 16,635	1.10 Covid 19 Aid to Impacted Industries	Meals on Wheels would like to add additional funding to be available to support LTE positions to the program to help with fill ins for current staff as well as additional support. This will allow for extra tasks to be completed as well as maintain day to day operations as demand continues to increase.
CTH G / Bush Brothers Drive Improvement Project	\$ 367,435		The City of Augusta is currently replacing water and sewer along CTH G. From USH 12 west 2,500 the road is in poor condition and the sewer manholes need to be resealed and adjusted. From Bush Brothers Driveway east 2,000 the roadway will be rebuilt due to the new watermain and pumphouse installation that the City of Augusta is paying for. The goal of this project is upgraded water and sewer service for the City of Augusta as well as a new roadway for Eau Claire County. Conference Room AV for Hybrid Meetings	\$ 147,000	1.7 Other Covid 19 Public Health Expenses including Communcations Enforcement Isolation Quarantine	Configure three larger conference rooms and one small conference room with appropriate audio visual equipment to hold hybrid county committee meetings. This equipment would be able to allow participants (remote or local) to properly hear the meeting conversation, see video and content being displayed.
Western Wisconsin Nurse- Family Partnership Consortium	\$ 125,000	2.12 Healthy Childhood Enviroments Home Visiting	ECCCHD is requesting funds through the Eau Claire County allocation of American Rescue Plan Act of 2021 to hire and train a full-time Nurse-Family Partnership Nurse Home Visitor (NHV). This NHV would receive the required training, carry a caseload and shadow our current Nurse-Family Partnership Nurse Supervisor. Our current Supervisor is planning to retire in mid-2023 and this NHV would transition into the supervisory role upon her retirement. Homelessness and Housing Support	\$ 411,314	1.12 Mental Health Services	This project provides coordination of Housing and Homelessness services with community providers through service collaboration, provision of mental health services and resource coordination with our community providers. In addition, we know that connecting with individuals experiencing homelessness and mental health or substance use disorder issues requires an understanding of mental health, concepts of trauma, and ability to connect with individuals. The project framework is to expand the existing certified crisis program, to provide outreach and services to the homeless population. This resolution extends the existence of the Broadband Special Committee on rural broadband. The committee was charged with the function of identifying under-served rural areas and gaps in broadband service. In addition, the committee continues to identify potential strategies to improve access in areas of the county that are under-served or unserved with highspeed internet, identify funding resources, and recommend cooperative ventures with internet service providers to improve rural broadband coverage.

Previously the County Board approved resolution 19-20/020 that created the committee for a period of 12 months. Resolution 20-21/080 extended the committee existence for another 24 months to October 2022. The committee has remaining work to support the extension of highspeed internet in the County, therefore approval of this resolution will allow the committee to complete its work on a final plan to improve access to broadband services in the County.

The Broadband Committee at its meeting on August 25th, 2022, voted unanimously to recommend approval of the resolution 22-23/047 to extend the existence of the committee.
