

# Minutes for Board of Canvas - February 22, 2021 For the Spring Primary Election held February 16, 2021

Monday, February 22, 2021 at 9:00 a.m.  
Eau Claire County Courthouse, Room 3312

At 9:00 a.m. the Board of Canvas convened with Shauna Ponty, a Democrat, Carol Cox, a Republican and County Clerk Sue McDonald present to canvas the results from the February 16, 2021 Spring Primary Election. Nick Koerner from the City of Eau Claire Elections office was also present.

County Clerk Sue McDonald administered oaths of office to the Board of Canvas members Shauna Ponty and Carol Cox.

All reporting information was present. A tabular report for the race of State Superintendent of Public Instruction was given to each canvas member. This report was used to confirm correctness when comparing each reporting unit's signed by poll workers individual results tapes from election night.

The total voters from the Inspectors' Statement was compared to the total vote counts per reporting unit for the top race, which in this case was the only race on the ballot being canvassed, the State Superintendent of Public Instruction to make sure there was no great drop off of voters to ballots cast. County Clerk Sue McDonald read the individual tape for each reporting unit and Shauna Ponty and Carol Cox compared that number to their canvas report totals.

The following is information per reporting unit of voters listed on the Inspectors Statement and ballots cast for the State Superintendent race. Where there is an asterisk there is a difference in the totals with an explanation of why that is:

The municipality sorted the ballots on election night and determined the number for Sheila Briggs needed to be reduced by one as the ballot that was counted twice. Also there was a provisional ballot returned that needed to be added in to total. So 204 is the correct number of voters.

\*\*The Town of Wilson had one blank ballot go through accidently and that voter was given another ballot. Also they skipped #6 when assigning ballot numbers to voters. So the correct number should be 15 voters and 15 ballots.
