Chair Leary called the meeting to order at 1:00 pm.

- 2. Such recommendation will suggest which organization or department will have management responsibility.
- 3. Provide recommended County budget for 2024, if any.
- 4. Support recommendation with due consideration from multiple interested parties, and assure any regulatory restrictions are addressed.
- 5. Provide an interim report to Land Stewardship Subcommittee by June 30, 2023.
- 6. Land Stewardship Subcommittee to submit a final report to LCC by July 31, 2023.
