Update – Market Sounding process

I'm writing this update in my role as the Project Director (appointed by the Commission Chair per the contract with RBC) on behalf of the Commission for the Market Sounding project.

Commission Chair Jim Dunning and Commissioner Ann Schell and I have been working with Ray Chambers and Mason Baxter from RBC Transportation Solutions LLC on the implementation of the Market Sounding engagement. As discussions have moved forward with the AIPRO member carriers and the host railroad, Union Pacific, a two-stage process has emerged.

- 1. Host Railroad Meeting: Because of the critical nature of the relationship with Union Pacific regarding prospective terms for the use of its infrastructure, anticipated operational issues, and potential needs for capital improvements, RBC recommended a pre-meeting with UP before the full Market Sounding event. This meeting has been scheduled for Monday, December 12, with key officials at UP's headquarters in Omaha. Scott Rogers will attend in person on behalf of the Commission, along with Ray Chambers and Mason Baxter from RBC, and representatives of the AIPRO member contract operators. Jim Dunning and Ann Schell will attend remotely. Some of the meeting topics will be confidential that involve the potential commercial relationship between the contract operators and UP regarding the service implementation.
- **2. Full Market Sounding event:** The discussions with UP will set the stage for the full Market Sounding event, which is now anticipated to take place in early February. This will include all stakeholders, service and equipment providers, and other interested parties as a prelude to the Commission applying for entry into the FRA corridor program. As FRA representatives indicated at our October 26 Commission meeting, the deadline to apply to enter the program is likely to be mid-March (presuming the program details are published in mid-December as expected).

At our December 14 Commission meeting, we should be able to report on the Union Pacific meeting on Monday and expectations for the Market Sounding. We expect RBC shortly thereafter will get the event scheduled, report on all implantation aspects related to submitting a successful application to FRA, and provide a detailed agenda.

Budget question: As we've previously discussed, the contributions to the Commission from member entities provides some excess funds beyond the contract with RBC to have funds available for other expenses related to the Market Sounding and the Commission's work. Since RBC strongly recommended having the Commission represented in person at the Omaha meeting, I booked a flight and hotel to participate. I would appreciate it if the Commission would consider reimbursing my travel and hotel for the meeting. This would include \$437.50 for the flights, \$104 round trip shuttle to MSP, \$70.31 for lodging in Omaha, plus transportation to and from the Omaha airport. The total will likely be \$630-\$650.
