Approval of Full Council Meeting Minutes from August 17, 2022

One correction to presenter of Probation Presentation, recorded as Dan Bresina, will be changed to Mike Felton. No other corrections, deletions, or additions. All in favor of approving the minutes from August 17, 2022.

Review of General Budget

- -Lieske Giese mentioned there is discussion about decreasing the budget for DHS. Mentioned that early intervention makes a difference
- -Kathryn Schauf said the state of Wisconsin overall is focusing on crisis services reduction, and the state is increasing the budget for crisis services

System Updates

- Covid in Jail/Huber Center
 - O Dave R gave an update that huber is still shut down-no additional updates. There is a possibility is could open in early 2023.
 - O Dave R went over what the criteria is for electronic monitoring. There are 35 units total and currently 20 of them are being used right now
 - o Nick S asked about isolation in the jail, as of right now covid protocols are still being taken
 - Judge Schumacher commented on covid and people appear remote for their court hearings. The county is moving in the direction of all in-person court.
 There was a question on if the Huber Center is still closed due to staffing or Covid protocols,
 - O There was a question on if the Huber Center is still closed due to staffing or Covid protocols, Dave R said it is a combination of both.
 - o Nick S asked if there are some people in jail that would have done Huber if it was open. Dave

- said there are some people in jail that might have met criteria for Huber, but don't meet the criteria for electronic monitoring.
- o Tiana G commented on the impact of the Huber being closed and the OWI program
- o Lieske G gave an update from the Health Department relating to Covid and the jail
- Citizen Group Update
 - o Tiana G gave an update, she has a meeting coming up with JONAH, an update on this will be given at the next CJCC Council meeting
