Dear Secretary Thompson:

The Chippewa-St. Croix Rail Commission respectfully requests the Wisconsin Department of Transportation take the following steps to respond to the December 20, 2022, solicitation of the Federal Railroad Administration for the designation of passenger rail routes for its Corridor Identification and Development Program:

- 1. Submit, as the primary applicant, the route between Chicago, Milwaukee, Eau Claire, and the Twin Cities. This is a corridor in Wisconsin's State Rail plan, which utilizes the current Amtrak route, and/or a route via Madison, to Camp Douglas, then the Union Pacific Railroad to the Twin Cities.
- 2. Support and provide technical assistance to the Chippewa-St. Croix Rail Commission for its anticipated application to FRA for a multi-frequency Regional Corridor between Eau Claire and the Twin Cities on the Union Pacific via Menomonie, Baldwin, and Hudson/River Falls.

The Commission submitted each of these routes to FRA as Expressions of Interest on September 21, 2022. Since the through route would represent an extension of and be complementary to the state's current Amtrak-operated passenger rail program, it is most appropriate for WisDOT to take the lead in its planning and implementation. In the case of the Eau Claire-Twin Cities Regional Corridor, the Commission is pursuing an alternate implementation concept, working with potential independent contract operators and the host railroad. It would be important for both of these initiatives to be closely coordinated. WisDOT has the experience, institutional capacity, and key role serving the state's transportation interests that make it appropriate for it undertake both roles that we suggest here.

The Commission, representing Wisconsin counties, municipalities, and stakeholders on the corridor, commits to be closely involved with WisDOT throughout this process, coordinating the involvement of local jurisdictions and committing local staff and resources as feasible. It also will consult closely with WisDOT for its expertise and advice as its Regional Corridor application is completed.

The FRA Corridor Program represents a truly unprecedented opportunity to improve transportation options for Wisconsin citizens. We hope we can look forward to working with WisDOT to make it a reality.
