1st offense: Animal in question will be disqualified from show and will not qualify for any prize money or champion awards.

2nd offense: Exhibitor will be disqualified from any further participation at the current Wisconsin State Fair. This disqualification will be for all departments and prize money earned. Exhibitors may also be barred from participating in future Wisconsin State Fairs.

4-H leaders, FFA Advisors, Volunteer Adult Contacts, industry professionals and others are encouraged and allowed to give verbal or written educational instructions. This is an educational activity and learning by doing is Wisconsin State Fair's mission.

Enforcement of compliance will be based on visual observation of the infraction by the Wisconsin State Fair Fitting Superintendent or his designee.

Animal holders are not permitted to groom animals while waiting.

All exhibits must remain on the grounds until 4 pm on Sunday.

State aid may not be paid on exhibits removed from the fairgrounds before 4 p.m. on the last day of the fair, or such other later time as may be specified by the fair, without prior approval of the department.

The penalty for violating this is \$50.

General rule infractions:

1st offense-written warning and asked to leave.

2nd offense-banned from the fair.

If Wisconsin State Fair Park Management suspects a violation of the Show Ring Code of Ethics and/or published Wisconsin State Fair rules/regulations will occur if an animal is shown, and the violation is reasonably well-established before the animal is shown, WSFP Management will discuss the potential violation and possible actions with the exhibitor; and:

1) if, at the exhibitor's discretion, the animal in question is not shown, no violation will have occurred.

2) if the exhibitor wishes to challenge WSFP Management's decision that a violation will occur/has occurred; the exhibitor will have the opportunity to submit an official protest and enter the WSFP decision review procedures. If the decision is upheld, the exhibitor will be denied the opportunity to exhibit the animal in question.

Violations are subject to the disciplinary provisions of Show Management. Sanctions may include any one or a combination of the following:

□ forfeiture or return of awards, prizes, prize money, or proceeds.

u written letter of reprimand to the owner, exhibitor, fitter, or responsible person.

 \Box disqualification of the exhibition livestock from an exhibition.

 \Box disqualification of the exhibitor from the show.

□ publication of offense (as these actions may be subject to open records review).

Disqualification may include any or all shows/classes for an indefinite number of years.
