- 1. Call to Order: Chair Bill Hilgedick called the meeting to order at 7:30 am.

- **3. Roll Call:** Commissioners Rick Bowe, Scott Francis, Bill Hilgedick, Chuck Hull and Barry Wells were present. David Hirsch arrived at 7:36 a.m.
- 4. Approval of Minutes:
 - a. January 20, 2023 Regular Commission Meeting:
 On a motion by Com. Wells, seconded by Com. Bowe, the minutes of the January 20, 2023, meeting were approved as submitted.

- 5. CVRA Finance and Activity Reports:
 - a. Expense Vouchers, Credit Card Charges and Financial Report:
 On a motion by Com. Francis, seconded by Com. Wells, the expense vouchers for November were approved as submitted.

 - Commissioner Appointments: Commissioner Bowe announced that he would not seek another reappointment to the Airport Commission, so Chippewa County is seeking residents of Chippewa County to serve on the Commission.
 - **Airport Community Outreach:** The Commission reviewed the Airport Community Outreach opportunities and events.
- b. Airport Strategic Plan Update/Review:
 - **Operational Review:** The Operational Review for February covered staffing.
- c. Project Summary
 - AIP 48 Rwy 4/22 and Taxiway A Rehabilitation FY22: No update.
 - **AIP 49 ARFF Building Reconstruct– FY22:** In progress. Substantial completion expected for mid-March.
 - **AIP 50 Master Plan Update FY22:** Public Open House took place on February 16th. Information on the open house is available on the airport website.
 - AIP 51 Phase II Design and Construct Wildlife Fence and Wildlife Study Recommendations FY22: The tree clearing portion of the project is underway. The Commission previously approved the option to contribute to the 300 acres of trees being planted in Clark County and had further discussion about the two options to contribute to Eau Claire County.

On a motion by Com. Francis, seconded by Com. Hirsch, a proposal to allocate \$20,000 to the Eau Claire Country Land Stewardship account to be spent on wildlife habitat or tree planting failed.

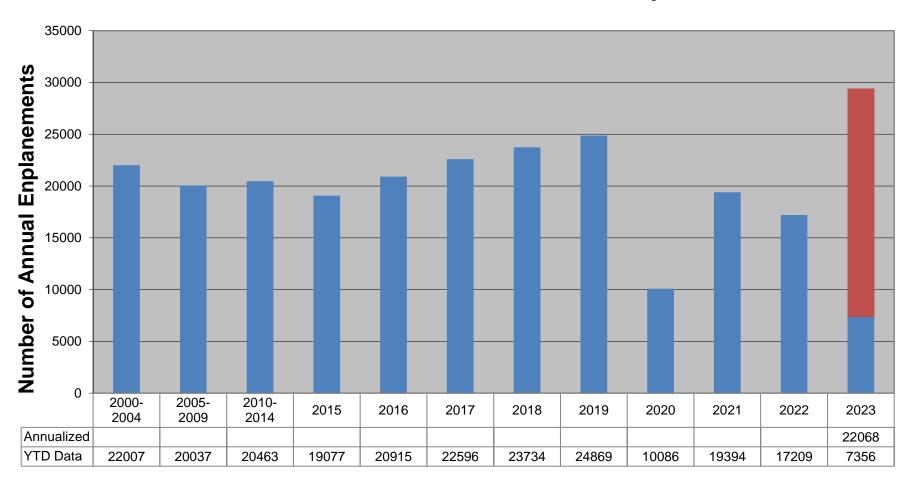

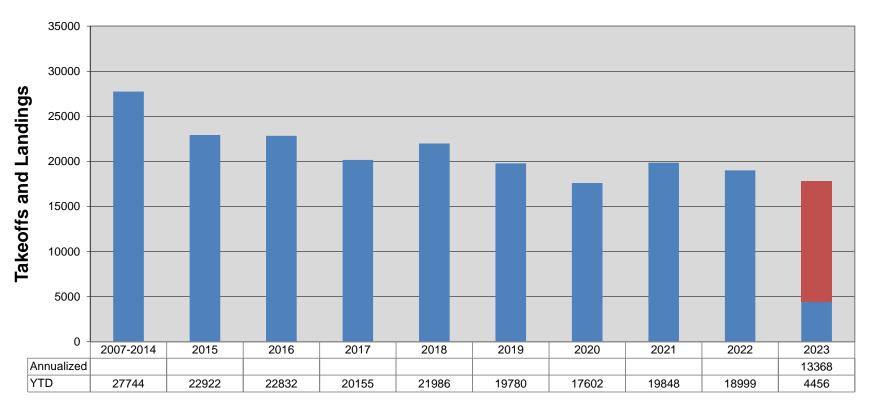

CY2022 ANNUAL REPORT

Vision

The Chippewa Valley Regional Airport will provide our users with a safe, efficient and welcoming operation while striving to meet the current and future needs of the community we serve, by ensuring the Chippewa Valley is connected to the world.

2022 Accomplishments

Commercial Airline Service

Scheduled daily airline operations at the Chippewa Valley Regional Airport (CVRA) have been provided by United Express with service to Chicago O'Hare since 2010. In March 2022, the United Express carrier serving CVRA, SkyWest Airlines, announced termination of service to CVRA and 28 other airports as the result of a nationwide shortage of pilots. After a US DOT led RFP process, Sun Country Airlines was selected to serve CVRA for a two-year contract period starting on December 1, 2022. Sun Country Airlines was selected as the best opportunity to serve the largest amount of travelers over the next two year term. Despite only being required by the DOT contract to provide two flights per week total, Sun Country is currently providing four flights per week to the Minneapolis-St. Paul International Airport with connections to flights in the Sun Country network and two flights per week to a rotating seasonal destination. The current rotating seasonal destination schedule includes nonstop flights to Fort Myers, FL in the Winter, nonstop flights to Orlando, FL in the Spring/Summer and nonstop flights to Las Vegas, NV in the Fall.

The larger Boeing 737-800 aircraft used by Sun Country has not previously served this airport on a scheduled basis and the new larger aircraft brought significant operational changes. The most significant challenge was a federally mandated change to the airport security program. The new security program was a major change from the prior program and while all the details cannot be shared due to federal regulations, it required a massive amount of staff time to ensure that we had the new program developed and implemented prior to the start of the Sun Country service. Without our entire team working together, we could not have met the deadline.

After a strong year over year increase in passengers at the start of 2022, reduction in frequency of flights leading up to the departure of SkyWest Airlines from the market led to a decrease in airline passengers in 2022 over 2021. However, even with a more than 30% reduction in the number of scheduled airline flights in 2022 versus 2021, CVRA ended 2022 with only 12% less passengers than 2021. Total revenue airline passengers in 2022 were 34,594 compared to 39,167 in 2021.

General Aviation

Demand for general aviation facilities continues to be strong at CVRA. Airport hangars were at 100% occupancy for the first half of 2022 and 95% occupancy for the second half of the year with 60 of 63 hangars rented. Additional demand continues to exist for larger aircraft storage. Design was started on two projects to add general aviation hangar storage space in 2022 with construction planned for 2023.

Tower operations were down slightly in 2022 with 18,999 aircraft operations recorded versus 19,848 aircraft operations in 2021. Aircraft operations include airline and general aviation takeoffs and landings during the tower hours of operation which are 5:30 a.m. to 8:30 p.m. Additional aircraft operations occur outside the tower hours but there is no mechanism to count that traffic.

The airports fixed base operator (FBO), Hawthorne Aviation, continues to provide essential services for general and corporate aviation including aircraft rental, fueling, heated hangar rental and on demand business and medical charters. Total gallons of fuel delivered to the airport in 2022 was 1,070,834 gallons which was slightly less than the 1,163,738 gallons delivered in 2021.

A new business, Gibson Aviation, started providing flight instruction at CVRA in 2022. Gibson Aviation has been a great addition to CVRA, offering multiple aircraft and flight instructor options for new students interested in flight training.

Airport Partners

Four car rental brands, Avis, Budget, Enterprise and National, were available at CVRA in 2022. Cars rented at the airport continued to increase year over year with a total of 5,193 in 2022 which was an increase of 8% over the 4,794 cars rented in 2021. Increased car rentals continue to keep car rental concession revenue high when compared to prior years.

Hangar 54 Grill, the full-service restaurant and bar that opened at the airport in 2016, continues to be an asset to the airport and the community. With increasing business, Hangar 54 expanded hours of operation back to their pre-COVID schedule in 2022.

Airport Capital Improvements

Construction began on a new airport owned 25,000 square foot hangar in 2022, with the hangar to be leased by Hawthorne Aviation. The new hangar will allow Hawthorne to pursue large cabin business aviation jets that cannot be accommodated currently in any hangar space at CVRA.

A project to rehabilitate the main airport runway and associated taxiway was completed and construction on a replacement Aircraft Rescue and Firefighting (ARFF) building started in 2022. The ARFF facility is designed to accommodate the larger trucks necessary to meet FAA requirements for having airline service. Construction also started on the first phase of the perimeter fence replacement project in 2022 and the airport parking revenue and access control system was replaced.

Federally funded projects generally have 90% of the federal funds coming from the Federal Aviation Administration Airport Improvement Program (AIP) through the Airport and Airway Trust Fund (AATF). The AATF provides funding for the federal commitment to the nation's aviation system through several aviation-related excise taxes. State projects are also funded at least partially by aviation user fees. Local project commitments are funded with existing airport funds. No new tax levy dollars are requested for airport projects.

2023 Future Opportunities/Challenges

Loss of daily scheduled service in 2022 was very disappointing to many in our region, but many travelers are also very happy to have a low cost carrier like Sun Country Airlines in our market. CVRA is committed to maximizing the number of travelers using our facilities through support of the carrier that is serving the airport by helping to inform the community of the transportation options at the airport. We will also continue to do everything we can to inform the traveling public about the benefits of flying from their local airport. Low cost parking, short security lines and now an ultra low cost airline are advantages to traveling local that we will continue to aggressively promote to travelers in our region.

The shortage of pilots is ongoing and continues to threaten airline service in small communities, but the team at CVRA is committed to continued work toward the opportunity to have daily scheduled service return to our community. We will continue to advocate for both short term and long term legislative change that will help reduce the shortage of pilots and allow regional airlines to return to serving markets like the Chippewa Valley. Ongoing additional efforts related to the new airport security program will continue to have an administrative burden on CVRA that may need to be addressed through additional staff resources.

The CVRA team will also continue to focus on opportunities to grow the corporate and general aviation utilization of the Airport. Despite the continued investments in hangar facilities in the last few years, there is still opportunity to accommodate additional aircraft. Growth in this area of the airport is just as important to long-term success as the growth in airline related business.

Several exciting projects are planned for 2023. The Airport Master Plan Update process will kickoff in 2023 with several opportunities for public and stakeholder input. Another new corporate development partnership agreement is expected to be reached to construct a new hangar at CVRA. Design is also in progress for a new multi-unit box hangar which will accommodate a few of the aircraft currently on our waiting list. A new airport fire truck will be bid in 2023, along with the second phase of the perimeter fence project.

Commercial Airline Service

The Chippewa Valley Regional Airport provides support for commercial air service operations. The commercial air service program includes everything having to do with facilitating, serving and maintaining commercial air service, including Aircraft Rescue and Firefighting, Federal Aviation Administration Airport Certification, Transportation Security Administration Airport Security Program, air service marketing and public relations, facilities and maintenance for the airfield, terminal building, air traffic control tower, parking lot and entrance road.

Airfield Infrastructure including Runways, Taxiways, Aprons, Approaches and Navaids

- Runway 22: This is the primary runway and the only runway with a precision approach or an Instrument Landing System. Aircraft can land with 200 foot ceilings and a ½ mile visibility. The airport owns and maintains a Precision Approach Path Indicator (PAPI) on this runway end.
- Runway 04: This is the second most utilized runway. This runway has a non-precision GPS approach with the lowest minimums being 200 feet ceiling and 3/4 mile visibility. The FAA owns and maintains the PAPIs and Runway End Identifier Lights (REIL) on this runway. The threshold on Runway 04 was relocated in 2016, adding an additional 400' for landing on this runway. A 400' displacement still exists on this runway.
- Runway 04/22 was last completely reconstructed sometime in the early 1980's and an 800 ft. extension was added in the late 1990's on the Runway 22 end. An FAA funded project to complete some partial/full panel repairs, joint sealing and remarking occurred in 2022.
- A strategic plan action item is to study the cost/benefit of adding approach lights to Runway 04. This review will be done as part of our Master Plan update which is ongoing in 2023.
- Runway 14/32: This is our crosswind runway. Improvements to extend the life of this runway were completed in 2020.
- Currently only visual or circling approaches with higher minimums exist to this runway. The FAA will consider the possibility of GPS approaches to both runways once the Airport Layout Plan showing these approaches is approved. It is highly unlikely we will get very low minimums at this time on Runway 32 due to the large number of obstructions in the approach path. Runway 14 may be able to obtain lower minimums.
- Runway 14 has a PAPI and REIL and Runway 32 has a PAPI all owned and maintained by the airport. The FAA has indicated a REIL must be added to Runway 32. This will be added into a future FAA funded project but will be owned and maintained by the airport.
- <u>Taxiway A</u>: This taxiway is the full parallel taxiway serving Runway 04/22. It was reconstructed from taxiway C south to taxiway A4 in 2017. Taxiway A from taxiway C north and connector taxiways A1, A2 and A3 were rehabbed in 2017. Taxiway A lighting from B2 to A1 was replaced in 2020.
- <u>Taxiway C</u>: This taxiway is the full parallel taxiway to Runway 14/32. It was reconstructed from taxiway C2 to taxiway C1 in 2010 and from taxiway connector C2 to C4 in 2016.
- <u>Taxiway E</u>: This taxiway provides access from the south hangar area to runways 22 and 14/32. Taxiway E is in good condition with periodic remarking needed.
- <u>Taxiway F</u>: This taxiway provides access to runway 04 from the south hangar area. Taxiway F requires occasional crack sealing and remarking but is otherwise in good condition.
- <u>Hangar Taxiways</u>: The taxiways leading to our north hangar areas were reconstructed in 2005/06 and are in good condition, with the exception of taxilane J. The K-row taxilane was constructed in 2005 and the N-row in 2018. Rehab of the K-row and J-row taxilane and an

- expansion of Taxilane L is planned for 2024. Occasional crack sealing is needed on all hangar taxiways.
- <u>Terminal/FBO apron</u>: All areas were joint sealed and partial/full panel repairs were completed in 2015. The north end of the apron had some asphalt portions removed and replaced in concrete and a concrete section was also added to the south end of the apron in 2014/15. The terminal area apron will be studied as part of the Master Plan to determine better flow for the larger Sun Country aircraft.

Mowing Operations

- Landside areas adjacent to sidewalks and roads are maintained at 3-6" grass height.
- Landside areas beyond about 20' from roads and sidewalks are kept at 6-12".
- Areas adjacent to airfield pavement are maintained at 3-6" grass height.
- Airfield areas beyond 12' from pavement are kept at 6-18".
- Remote areas that are able to be mowed are maintained on an annual or bi-annual basis. Additional mowing areas will be created with the fence project in 2023.

Mowing Equipment

Mowing equipment is not eligible for federal funds. The airport owns the following mowing equipment.

- 1. 2020 Toro Groundsmaster 4110 mower with a 10'6" finish deck
- 2. 2014 Tool Cat 5600 with a 72" finish deck
- 3. 2020 NewHolland T6.155 Tractor with John Deere 20' wide pull behind deck (mower purchased in 2015)

Snow Removal Operations

- The annual airplane operation count for this airport requires a clearance time for Runway 04/22 and Taxiway A in one hour.
- Halliday Technologies RT3 Flight continuous friction measuring equipment (CFME) is used
 to conduct friction testing during winter operations. This device was purchased in 2014 and
 is a very consistent tool for providing friction testing.
- Notices to Airmen (NOTAMs) are issued by the airport maintenance staff using a digital format.
- Changing FAA requirements for reporting runway conditions has placed a greater focus on sweeping operations and use of chemicals to remove contaminants from the runway. The airport grounds maintenance budget has been adjusted in recent years to account for additional funds for chemicals and the airport recently purchased new equipment to facilitate greater sweeping capabilities.

• Airport maintenance personnel are responsible for determining airfield clearing priorities depending on conditions and time of day. The following priority list is used as a guide.

Snow Removal Equipment

- Additional snow removal equipment purchases to replace aging equipment is planned for FAA funding in the next couple of years. Additional purchases to replace non-federally eligible equipment like a front end loader will likely be needed as well.
- One challenge with new equipment is ensuring the size of the equipment is able to fit into our existing maintenance facility. A new bay and expansion of the door on an existing bay was completed in 2021 to accommodate larger equipment.

76% of US airports have substantially less air service today than before the pandemic, despite rising passenger demand. A real and growing pilot shortage stands to worsen air service loss unless we take action.

Rally for Air Service is a coalition that has come together to communicate the negative impacts of the pilot shortage across the United States so that solutions can be advanced to help prevent the damaging economic impacts of the loss of air service. We represent a wide range of stakeholders who have a shared interest in addressing the shortage and preserving and rebuilding air service.

Our Mission is to educate the public about this worsening situation and encourage solutions that preserve and enhance aviation safety, allow greater and more equitable access to pilot training, and preserve and restore air service in the United States.

Communities are losing air service due to the shortage of airline pilots.

- There aren't enough pilots to meet forecasted demand for air travel. As a result, airports across the country, especially in small communities, have faced dramatic air service loss that worsened during the summer travel season.
- Air service loss imparts devastating consequences on the economies of these communities and diminishes the quality of life for residents.
- We are already seeing the impacts on small communities, including but not limited to those communities that rely on the Essential Air Service Program, which is facing a crisis of air service terminations.
- Domestic demand has met or exceeded 2019 levels, yet the majority (76%) of US air service receive far less air service today than before the pandemic. Official Airline Guide (OAG) schedule comparisons between October 2019 and October 2022 show that 324 airports have lost flights, with an average service reduction exceeding 31%. Further, 161 airports have lost more than 25 percent of their air service, 112 airports have lost more than 1/3 of their flights, 60 airports lost more than half their flights, and 14 airports have lost all scheduled, commercial air service.
- The pilot shortage is the single, driving factor behind this crisis.

The pilot shortage is a major problem and is growing worse.

Large air carriers expect to hire more than 13,000 pilots over the course of this year, yet FAA issued an average of just 6,335 new ATP/RATP certificates per year since 2013. Pandemic forces slowed this further, with fewer than 5,000 new ATP/RATP pilots certified in 2021 and fewer than 4,000 in 2021. While 2022 is on track to produce higher than average new certificates, the number falls well short of need and is consistent with clearing the backlog of paused certificates during covid rather than a long-term uptick in supply.

- Major airlines primarily hire from smaller, regional air carriers, which provide the only source of air service to more than two-thirds of the country – communities too small to support air service by the major airlines.
- With far too few new pilots being produced to replace those hired by bigger carriers, worsening air service losses will be most acute at regional airports and smaller communities.
- Some of the largest hub airports will experience air service loss as well, particularly major gateways to smaller communities. Regional airlines provide significant departures at major hub airports like ORD (62% regional), DFW (47%), CLT (56%), DEN (33%), IAH (55%), DTW (54%) SEA (40%), ATL (22%), MSP (47%) and PHL (52%).
- The pilot shortage is a network problem with sweeping consequences across the entire aviation system.

There is currently an unprecedented demand for airline and commercial pilots.

- The Bureau of Labor Statistics (BLS) projects that from 2021-2031 there will be an average of approximately 18,100 openings for airline and commercial pilots <u>each year</u>. This demand is driven by two primary factors:
 - FAA data indicates that over 13% of airline pilots (13,820) will reach mandatory retirement age of 65 over the next 5 years. This number increases to 47% of airline pilots within 15 years (48,680.)
 - Early retirements during the pandemic exacerbated the problem with between
 5,000 and 6,000 pilots at large air carriers exiting the profession.

There are too few new pilots to fill the void.

- The FAA certifies on average just 6,335 pilots per year who have the credentialing necessary to be hired by commercial and cargo airlines. Additionally, corporate and business aircraft operators also frequently require the same pilot credentialing as airlines.
- High barriers to entry, block the career path for too many. Flight education and training alone costs \$80,000 on average, and when incorporated to a professional pilot degree program, the total expense can exceed \$200,000. Unlike other prestigious and high-earning career paths like doctors and lawyers, aspiring pilots don't have access to additional federal student loan aid to help cover the higher education and training costs. As a result, only the wealthy and those with access to private capital can follow their dreams and become a pilot.

<u>Goals</u>

Near and long-term solutions are being discussed across the industry, with goals to preserve and restore air service while continuing to have the best trained pilots in the world. Addressing the pilot shortage will not and cannot adversely impact aviation safety, which is the hallmark of the U.S. aviation industry. We can and must allow greater and more equitable access to pilot training, enhance aviation safety, and preserve and restore air service in the United States.

Dear Chairman Graves, Ranking Member Larsen, Chair Cantwell, and Ranking Member Cruz:

We are the Rally for Air Service Coalition, a group formed to communicate the harms of the growing pilot shortage on our aviation system and local communities, and to urge meaningful policy solutions. Our membership includes airports, chambers of commerce, economic development organizations, educational institutions, and many others. As you know, Congress has sought to address growing workforce shortages, including the pilot shortage, including measures in the last two Federal Aviation Administration (FAA) Reauthorization laws. Unfortunately, the pilot shortage that began nearly a decade ago has grown to alarming proportions and has resulted in air service collapse in many parts of the country, with real and devastating impacts on our airports, communities, and way of life. Therefore, we write to share our serious concerns regarding the pilot shortage and to urge your committees to take further action to remedy the shortage and the cascade of harms it has imposed.

Today 324 airports, a shocking 76 percent of the countries' commercial airports, have substantially less air service than before the pandemic. This is overwhelmingly due to the pilot shortage and has occurred despite rising passenger demand, a return to pre-COVID pilot employment levels, and historic pilot pay raises. On average these airports have lost 30 percent of their flights with the smallest airports suffering the greatest impacts. However, the loss of flights and connectivity is also occurring at large and medium hub airports. Acting as the proverbial "canary in the coalmine", in just the last two years alone, 14 U.S. airports have lost <u>all</u> scheduled, commercial air service and 53 airports have lost over half of their flights. Air service losses make it more difficult for communities to attract investment, generate employment, and provide mobility and vital services to their citizens.

The stark reality is that demand for pilots is far outpacing the available supply, which further exacerbates the existing shortage. Despite the return to pre-COVID demand for air travel and approximately 9,491 new pilots certificated in the last year, nearly 4,000 pilot qualifications were disrupted during Covid and more than 415 regional aircraft are currently parked and no longer in service. There are no signs that the pilot shortage and its devastating impact on air service will abate anytime soon. The pilot population is aging, and there are 70 percent more pilots aged 43-64 than there are pilots aged 21-42. Nearly half of today's qualified pilot workforce faces mandatory retirement within 15 years, and 2,225 pilots face mandatory retirement this year; more than 10 percent of the workforce must retire within 5 years. Even as the retirement crisis grows, prospective pilots face financial and access barriers to career training, which are insurmountable for individuals and families without wealth or the means to obtain private loans. For example, student loans do not cover the cost of flight education, and there are no financial supports available to pilots building flight time they are required to obtain before airlines may hire them. Such barriers not only constrain supply, they also hinder efforts to improve diversity among pilot ranks.

We respectfully urge your committees to take decisive actions to help alleviate the pilot shortage and to preserve and restore air service to communities across the country. Our communities are bearing the brunt of the pilot shortage crisis and we urge you to act now. Because solutions will take time to bear fruit, we urge policy efforts that focus on both long-term solutions and near-term supports. We need to work together to develop and put in place fact-based, safety-first solutions to provide greater pilot career access, create more high-quality pilots, and build upon the United States' incredible air safety record. Our communities and citizens are counting on Congress to take the lead to address this vital issue and we stand ready to assist you in your efforts. Thank you in advance for your consideration of our request.
