#### Evidence Based Decision Making Policy Team

Tiana Glenna presented an update for the EBDM (Evidence Based Decision Making) team. Eau Claire County Completed the SIMs (Security Information Management System) mapping and are waiting for the final report from the Technical Assistance providers. Once that is finalized this group will meet to determine action steps.

January 2022, Eau Claire County was selected as one of four nationwide to participate in the, National Center for State Courts TA (Technical Assistance) grant award for Mental Health Diversion. This is a six-month technical assistance award to look at Mental Health Diversion and Deflection options for the courts. This work will significantly overlap and support the SIMs review. A small workgroup has been established and will report out further at the next CJCC meeting.

#### Opioid Task Force

Tiana Glenna presented an update for the taskforce. A taskforce has been created by county board resolution. This taskforce has met three time. The Opioid Task Force will be tasked with recommending uses of the settlement funds to be used for opioid abatement purposes
