- 8. Eau Claire County Fair Committee By-laws and Mutual Respect Policy-Missy

By-laws presented with proposed changes per the recommendations of Corporation Council from Eau Claire County.

The following are changes made by Fair Committee:

A. MEMBERSHIP OF THE COMMITTEE:

Missy moves to add both voting or non-voting to the first line. Seconded by Letecia. (Committee members "both voting or non-voting" must not be of immediate family relation and living in the same household.) Voted 9 yes votes. Motion passes.

Missy moves to make the following changes: A first paragraph "The Committee will consist of Two (2) non-voting members and nine (9) voting members created from the following:

#2 Remove the highlighted text "If voting member(s) is appointed to a coordinator position, this position will remain vacant."

#4 Reduce youth members from 3 to 2 with one must represent livestock and the other must represent expo.

#6 will stay at 2 members

#7 will stay at 2 members

#8 and #9 will be combined to say "One member who is a either a member of Friends of the Fair, other than the Fair Coordinator or one member who is a member of the 4-H Leaders Association.

Scot seconds the motion. Roll call vote.

Kyle-Y, Missy-Y, Tammy-Y, Valerie-N, Scot-Y, Letecia-Y, Jenni-Y, Traci-Y, Darren-Y 8-yes 1-no Motion passes.

#3 Scot moves to add line stating "This person will act as the Livestock Liaison between the Fair Committee and the Livestock Project. Missy seconded. Voted and passed.

Tammy moves to amend #3 to add or the Eau Claire County Livestock Project. Missy seconds. Roll Call vote: Kyle-Y, Valerie-N, Letecia-N, Traci-N, Missy-Y, Scot-Y, Jenni-Y, Darren-Y, Tammy-Y. 6-yes 3-no Motion passes.

B. TERMS OF MEMBERS

- 1. Add #1 In 2023 a mew committee will be appointed with 1- or 2-year terms appointed by the Extension Committee.
- 2. Three members will begin their terms in the even years and the remaining four will begin their terms in the odd years.

Kyle moves to make the above changes. Scot seconds. Voted. Motion passes.

3. Change the "submitted no later than August 7th" Strike the sentences that read, " The Fair Committee will meet in August to discuss applications and make recommendations for appointments. The Fair Committee Chair will provide appointment recommendations to the Extension Committee Chair."

Kyle moves to make the above list changes. Scot seconds. Voted. Motion passes.

4. Missy moves make the highlighted changes: Members of the Fair Committee will not be voting members or executive board members of other organizations involved in fair activities e.g. Friends of the Fair and Livestock committee, unless they are appointed as a representative of that organization under section A. If

they are serving a term with these other organizations at the time of their appointment to the Fair Committee, they will step down from the other committees within 30 days.

Traci seconds. Roll call vote. Kyle-Y, Valerie-Y, Letecia-Y, Traci-Y, Missy-Y, Scot-N, Jenni-Y, Darren-Y, Tammy-N 7-yes and 2 no Motion passes
