Motion: Leary moved approval as presented Vote: 5-0, motion passes via voice vote

The committee reviewed the quarter 1 investment report.

Supervisor Sisk left at 5:15 pm.

Norb Kirk presented some rough projections for annual bonding in the \$5M-\$6M range for the next five years. Folstad wants a referendum in lieu of any borrowing strategy. Folstad would support an annual referendum of \$6M for specific purposes. The committee is open to a total borrowing amount of \$5M, with additional projects up to \$6M total, in the 2024 budget. The committee discussed options for short-term borrowing for smaller, recurring projects like squad cars and the lake district projects.

Advisory vote: capital should stay \$5M or less, 4-0 via voice vote

Addendum Item: 2024 Budget Guidance

Kathryn Schauf reviewed the 2024 budget guidance. The committee would prefer to see a 5% reduction required.
