Great Plains 1006NT Rental & Operating Agreement

The undersigned agrees to the following:

1. Pay a rental fee of a flat rate of \$75.00 plus \$8.00 per seeded acre to Eau Claire County Land Conservation Division (LCD). An invoice will be sent after seeding and payment is due within 30 days. Late payments will be subject to additional fees.
2. Keep the drill for no more than two days. The undersigned will be charged an additional \$50.00 per additional day the drill is kept;
3. Coordinate delivery and pick up with LCD staff, or other renters if necessary;
4. Have and provide proof of a liability insurance policy which is current and adequate to cover any damage or injury incurred through the transport or use of the drill;
5. Read and follow all manufacturer's recommendations in the owner's manual pertaining to use and operation prior to operating the drill;
6. Pay for any repairs beyond normal wear and tear while the drill is in his/her custody, including lost or damaged hitch pins and adapters;
7. Transport the drill with adequate truck or tractor capable of towing 4,500 pounds, at safe towing speeds not to exceed 30 MPH;
8. Calibrate the drill according to seed and field conditions. LCD staff are available to help with calibration. LCD is not responsible for failed seedings due to weather, improper drill settings or faulty seed, or any perceived or actual damage as a result of renting the drill from Eau Claire County LCD;
9. Use the drill with a minimum of 75 horsepower tractor with hydraulics;
10. Return the drill in the same condition as when it arrived. This includes overall cleaning, vacuuming seed boxes, and greasing zerks after use.

The undersigned agrees to defend, indemnify, and hold harmless Eau Claire County and its employees and agents, individually and collectively, from and against all costs, losses, claims, actions, and judgments arising from personal injuries, property damage or otherwise, however caused, that may arise from or be alleged to be caused by the undersigned's use, including transport, of Eau Claire County Land Conservation Division's Great Plains 1006NT drill.
