## Review and Approval of Minutes from May 11, 2023

## **Potential Program Proposals**

Peggy O'Halloran provided a presentation on three different program proposals.

Tim Rabolt motioned to recommend purchasing 8 sharps disposal containers for initial set up and one year of funding for no more than \$45,000 and 100 lock bags and 300 lock boxes for no more than \$12,000 for one year funding. Seconded by Dave Riewestahl. All in favor, the recommendation will go to the board.

Allen Myren motioned to recommend purchasing 250 Narcan units (2 doses/unit) at \$75/unit, and 250 Fentanyl test strip kits at \$6.50/kit for no more than \$22,000 total. Seconded by Ron Schmidt. All in favor, the recommendation will go to the board.

The Task Force requested for more specifics "Support for opioid/overdose educational efforts in community" be presented at a future meeting. The Task Force requested more information and for Ron to continue to explore more.
