Addendum Item - Specia Request by CDBG#93-12-05

This is a request by the son of the original owner of this mortgage which is \$9,113 in the Village of Fairchild. The mother passed away some time ago and the estate is not yet settled. The son states he plans to assume ownership but has not been able to finalize the estate. Staff are recommending approval of the request to make a downpayment on the loan of \$2,000 and monthly payments. Staff recommend minimum payments of \$50, and he can make higher payments when he is able. After some discussion, Swanhorst made a motion to reduce the downpayment requirement to \$1,500 to allow the son to apply the \$500 toward finalizing the deed transfer to get estate settled. Commissioner Vue seconded the motion. __5 ayes, _0 nays. Motion carried.
