Department initiative updates

Tiana Glenna has been meeting with all departments to talk about how effective we are as a CJCC, how can CJCC support your department, and where are the crossovers.

Pre-trial Services/Monitoring

James Deziel presented on Pre-trial services.

- Goals of the program are to maximize release of pretrial defendants, public safety, and maximize court appearances.
- The PSA gives defendant a level from 1-4, where level 1 defendants are the lowest risk and level 4 defendants have the highest risk. Most common across the state are levels 1 and 4.
- 87% of defendants in 2021- 2022 completed the pretrial process.

Treatment Courts - Luke Fedie

There is a policy change to allow people with pending misdemeanor cases to be admitted to a treatment court.

Starting July 1, there will be 1 treatment court with 2 different branches.

Other agenda items

Securing public defenders

Ryan Raymond presented on securing public defenders.

There is a staffing crisis throughout the state. Public defenders are paid \$70/hour while court appointed lawyers earn \$100/hour. In the new budget bill, public defenders would now earn \$100/hour.
