This project was already factored into the 2024 budget, while the exact number is not known yet Pedersen estimated the cost being roughly \$600,000. Once the grant application is submitted Pedersen will be notified of the decision by roughly June or July.

Supervisor Lepsch motions to approve Pedersen to apply for the grant and move forward with the project. All in favor.

Re: Chippewa Valley Trailriders Annual Report - 2023

Dear Josh,

The Chippewa Valley Trailriders (CVT) was organized in 1989 under a 501©7 Social Club status to unite a group of horseback riders interested in pursuing safe horseback riding options in Chippewa and Eau Claire County.

Following is an accounting of the volunteer hours the members of the Chippewa Valley Trailriders have expended in 2023 to develop, maintain and improve the horse trail systems in Eau Claire County.

Tower Ridge Recreation Area Horse Trails 147 hours

Volunteer work included removing downed trees and branches from storms and general trail maintenance throughout the year. In addition to the manual labor perform club members also used their own personal chainsaws and ATVs (including gas) and various hand tools to clear trails.

The Tower Ridge Horse Trails are very popular and are used by many horseback riders.

Backwater Horse Trails – 129 hours

Volunteer work included hand-brushing and clearing from winter and summer storms. Most of this work was performed on foot using chainsaws and hand tools for clearing. Work was also performed using an ATV for re-routing, marking and mapping trails on this property. Members also continue to exploring possible trail expansion options.

Hamilton Falls Horse Trails — **43 hours**

Volunteers worked to clear and maintain the trails. Tools used included chainsaws and various hand tools.

The total volunteer hours expended by CVT to maintain horseback riding trails in Eau Claire County totaled 319 hours. The Wisconsin Horse Council established a value for volunteer work at \$17/hour. Using this formula CVT has donated volunteer labor totaling \$5,423 in 2023 to maintain horseback trails in Eau Claire County.

2024 Plans include continuing to keep the Eau Claire County established horse trails maintained. In addition, club members will work with you directly to make improvements to the Backwater trails and parking area. The club has pledged \$2,000 toward a permanent toilet facility at Backwater Trailhead. The Hamiliton Falls horse trails also need some signing which will be discussed at an upcoming meeting with you this spring.

The Chippewa Valley Trailriders sincerely thank you and Eau Claire County for the opportunity to develop and maintain horseback riding trails in Eau Claire County. We remain dedicated to continuing a supportive relationship with the Parks & Forest Department.

TO FILE NO. 23-24/081

The county maintains approximately 20 miles of ATV/UTV trails and 181 miles of funded snowmobile trails throughout the county. The county is eligible to apply for maintenance funding annually for each of these programs from the Wisconsin DNR. This resolution will allow for the Parks and Forest Director to submit applications for maintenance funding, as well as capital improvement projects, for these motorized trail aids. The state ATV/UTV and snowmobile programs are funded at 100% reimbursement rate.

This resolution will also allow for the county to apply for motorized stewardship funding for motorized trails. This level of funding requires a 20% county or club match.

Fiscal Impact: Currently, our annual ATV/UTV trail maintenance funding level is around \$27,010. Our snowmobile maintenance is \$300 per mile, or \$54,360 annually. Together, maintenance funding alone is a \$81,370 positive impact.

This resolution allows the county to apply for matching funding for up to 50% of our costs for a planned capital improvement project at Lake Altoona County Park. This project would consist of additional seating and picnicking areas near the waterfront and include a new park pavilion. This project was identified in the Lake Altoona Park Master Plan and ties directly into the beach parking lot renovations that were completed in 2023. This project was approved during the 2024 budget cycle and was budgeted as a \$300,000 project.

Fiscal Impact: Grant reimbursement would provide approximately \$150,000 in revenue back to the county upon completion of the grant cycle.

Event Summary

In 2023, we expanded our previous 'Earth Week Challenge' to include more community events and celebrate Earth Day the entire month of April! Beaver Creek Reserve's new campaign is called 'Earth Day Every Day' to promote more community events, Beaver Creek programs, and long-term sustainability in the Chippewa Valley. Participants attend events the entire month of April, and at the end of each event, their names are drawn for raffle prizes donated by sponsors! We still host our annual 'Earth Week' as a designated week leading up to Earth Day to encourage visiting local county and state parks, to participate in our countdown to Earth Day Photo Contest, and attend our Earth Extravaganza event. Since starting this new 'Earth Day Every Day' campaign, we alone saw a major increase in participation in Beaver Creek events, and other activities going on in the community. **This was our outcome last year:**

• Virtual Programs: 7 total, 70 participants

• In-person Programs: 8 total, 155 participants

• Earth Day Event: ~100 attendees

Earth Week Open House & University of WI – Eau Claire (off-site outreach): ~400 attendees

Total: 18 total events = ~725 participants (WOW!)

Our Earth Day event, 'Earth Extravaganza,' will be Saturday, April 20th this year. This all-day event bleeds green! From a guided walk along our trails to learn about plants, wildlife, and pollinators, to making sustainable seed starters, building Bluebird houses, shopping around our Bird Banders Thrift Sale filled with second-hand, nature-y goodies, and ending the day with sweet Earth Day-themed treat... We'll be spending Earth Day with fellow eco-champions! **Our goal is to make this event FREE this year!** And with the help of sponsors, *like you*, we can make this possible.

Dear Josh

A little over a year ago you wrote a letter in support of the Eau Claire Ski Striders efforts to obtain a new groomer for Tower Ridge, (attached).

We appreciate your support and your efforts to secure \$50,000 for this project and hope you are as excited as we are about how this new equipment will benefit winter recreation for local and visiting skiers.

As you know on 11/21/2023 a down payment was made on a new Sno Rabbit. On February 12, we were informed by the dealer that the Snow Rabbit has now been outfitted with all the necessary attachments and is ready for delivery.

Excluding the County's \$50,000 contribution to this project, the Ski Striders have raised \$111,919 as of today. Most of these contributions were made last year during this time when we had plenty of snow and people were eager to support this project. Since that time, the group working on fundraising for the project has continued to work diligently to obtain the necessary funding to complete the project.

We intend to continue to work to raise the balance of funding necessary to complete the project. However, we want to formally request that you and the Parks & Forest committee consider contributing another \$10,000 to help us complete the project so you can take delivery of this new piece of equipment as soon as possible. Perhaps, the funds raised from passes sold this year could cover this additional amount. By using the pass fund, skiers who bought the yearly pass could feel good about buying one going into next year, knowing their funds were put back into trail system maintenance. We may even still have a chance to use the machine this season.

This winter ski season has been very discouraging for local skiers who are still hoping for a couple of good weeks of skiing this year. We hope you can see the value this equipment will add to your fleet and fast track this request so local skiers can see this piece of equipment in action this season.

Thanks for considering this Josh. We appreciate all your work and support.
