**Economic Development in the Eau Claire County Community**: Economic Development Corporation – Luke Hansen, Executive Director.

Luke discussed four pillars of ECAED

1. Business Recruitment. 2. Business Expansion 3. Entrepreneurs 4. Place making

Industrial development discussion:

-Gateway Industrial- Looking to expand the part of Gateway that is in EC county – No property in EC county left that is available, only Chippewa county space.

-Looking at other spaces. Looking for large parcels of contiguous acres. 100+ acre minimum

-Planning and development will share asset inventory from 2018.

-Acquisition planning should be considered should a parcel come up that would be desirable.

-Discussion on potential projects that could be considered if there was sufficient power and water resources available. -Funding is minimal for economic development. ECAED would request assistance to acquire industrial land as primary

need as well as funding. Incentives are a good option for recruiting.

-Educating decision makers is critical because of push back from public.
