

Parks and Forest

The Parks & Forest Department manages the timber sales, county forest roads, wildlife habitat improvement projects, and other operations on the county forest (52,712 acres), three county owned dams (Coon Fork, Lake Altoona, Lake Eau Claire), seven parks (Big Falls, Coon Fork, Harstad, L.L. Phillips, Lake Altoona, Lake Eau Claire, and Lowes Creek); three campgrounds (Coon Fork, Harstad, and Expo Center); Tower Ridge Recreation Area; Exposition Center, four cross-country ski trails, state funded countywide snowmobile trails, state funded ATV/UTV trails, hiking, mountain biking, horseback, disc golf, and hunter access trails; boat and canoe landings on three lakes and the Eau Claire River; and oversight of thirteen floodplain properties acquired by the federal Flood Hazard Mitigation Grant Program on the Chippewa and Eau Claire Rivers.

2021 Accomplishments

County Forest

- Adopted 2021-2035 County Forest Comprehensive Land Use Plan
- Finished forest road rehabilitation and graveling on Highline Landing Forest Road
- Straightening of Channey Forest Road and graveling project completed
- Control burn conducted on Black Creek Forest Road oak site
- 80 acres of oak scarified, ensuring forest regeneration back to oak species
- Successful SFI and FSC dual audit of county forest management program
- Trail and road building assistance for Lost Lake stabilization project with Lake Eau Claire District
- Continued work on Ruffed Grouse Society project off Stoney Lonesome Road
- Replacement and reconstruction of new culverts on all forest roads.

Parks

- New toddler playground and sidewalk installed at Lake Altoona Park
- Collaboration with Treasurer's office on receipting of daily and seasonal park pass deposits
- Fiber optic line installed to Coon Fork Park
- Mobility beach wheelchairs added for public use at Lake Altoona and Coon Fork Parks
- Concrete pad installation for payment kiosks to be installed in 2022
- Removal of hazardous trees throughout the park system
- Began installing all abilities access dock at Lake Eau Claire, project to be completed in spring 2022
- Tore down hazardous Harstad Park shelter, site prep for new shelter conducted
- Septic system replacement of beach restroom at Lake Altoona Park
- Began updating the comprehensive outdoor recreation plan

Expo Center

- Replacement of HVAC system on Exhibit building
- Exterior barn lights replaced with LED fixtures.
- Installation of new carded entrance system to Exhibit building
- Event numbers started to come back to near pre-pandemic levels
- Eau Claire County Junior fair was held with modifications.

ATV/Snowmobile Trails

- No new trail or bridge rehabilitation projects completed
- Closure of Troubled Waters Bridge for repairs to be completed in 2022
- ATV trail boom mowing completed.

2021 Future Opportunities

The effects of the COVID-19 pandemic continued to adjust the way we work and planned in 2021. Major budget reductions were put in place for the 2021 budget due to the pandemic and this resulted in a year of lesser seasonal staff than normal and also many less park projects taking place. The 2022 budget cycle offers some relief to staffing levels and project work, with more staff being brought on in the summer months and a return to pre-pandemic levels with park project work.

The implementation of a new outdoor recreation plan will help formulate a short-term plan for park improvement projects in the next five years. Many other exciting park capital projects are scheduled for 2022 including: new office building at Coon Fork, beach parking lot improvements at Lake Altoona, new parking lot and restrooms at Big Falls, new park pavilion and playground at Harstad Park, paving projects and installation of an RV dump station at the Expo Center, new park shelter at LL Phillips Park and installation of credit card payment kiosks at 3 of our park. This year will be one of the most exciting park development years in recent history. With almost every one of our main parks having a major capital project going on.

In addition, we will also be working on a county-wide parks master plan. This will help frame our next 20 years of park development projects and priorities within our park system. This long-term vision will help create a more cohesive update to our parks.

Forest management continues to be a tremendous asset to our department. Timber sales have stabilized, and markets continue to be strong with sawlog heavy sales, while the pulp market continues to fluctuate, and prices have remained low. The continued closure of the Verso mill in Wisconsin Rapids has continued to keep pulp prices lower than pre-pandemic.

Our motorized trails projects will be busy as well in 2022 with 2 new snowmobile trail bridges scheduled for installation. And repair work of the Troubled Waters ATV/snowmobile bridge scheduled to be completed in 2022.
