

# Parks and Forest

The Parks & Forest Department manages the timber sales, county forest roads, wildlife habitat improvement projects, and other operations on the county forest (52,712 acres), three county owned dams (Coon Fork, Lake Altoona, Lake Eau Claire), seven parks (Big Falls, Coon Fork, Harstad, L.L. Phillips, Lake Altoona, Lake Eau Claire, and Lowes Creek); three campgrounds (Coon Fork, Harstad, and Expo Center); Tower Ridge Recreation Area; Red Flint Recreation Area; Exposition Center, four cross-country ski trails, state funded countywide snowmobile trails, state funded ATV/UTV trails, hiking, mountain biking, horseback, disc golf, and hunter access trails; boat and canoe landings on three lakes and the Eau Claire River; and oversight of thirteen floodplain properties acquired by the federal Flood Hazard Mitigation Grant Program on the Chippewa and Eau Claire Rivers.

## 2023 Accomplishments

### County Forest

- Lake Eau Claire north boat launch redone and extended further into lake
- New ADA walk through gates installed at Big Falls North and LL Phillips
- Installation of 3 park credit card payment kiosks
- .40 FTE recreational deputy shared with Sheriff's and Highway Departments
- Installation of 2 rain gardens at Harstad Park
- All park buildings rekeyed to a 1 key master system
- Connector trail from installed from Coon Fork dayside to campground
- Implementation of campground store, with strong sales on most items for camper convenience
- Creation of floating park attendant model in summer to increase coverage throughout park system
- Standardized cleaning product usage within park system, resulting in a 30% reduction on supplies

## 2024 Future Opportunities

The department has another busy year that includes continued updates to many of our county park and recreation areas. Key new projects this year will consist of new playground installation and front entrance paving at Coon Fork campground, electrical service installation at Harstad campground, and continued pit toilet replacements throughout the park system. The department will also be applying for several large grants to help complete other projects including further work on the Lake Altoona Park master plan phasing, rehabilitation of the south boat landing on Lake Eau Claire, and installation of automation systems on Lake Altoona and Lake Eau Claire. Several other key pieces of our fleet will also be updated including a new parks mower, a finish mower for Toolcat, a new half ton truck, and new ski trail grooming equipment. Yet again, almost all our parks and facilities will have some sort of capital improvement project going on this year.

Staff will continue to plan and develop projects that have been identified in our outdoor recreation plan and our recently implemented Strategic Implementation plan. We also have a few carry over projects from 2023 that will be completed this year, with glamping structures being developed at Coon Fork, new doors at the Expo Center, and completion of phase 2 of the Lake Eau Claire clubhouse renovations.

Our newly donated recreation property, the Red Flint Recreation Area, will also be focused on for future developments. Initial plans will include installation of signage, hiking trail development, and discussion with DNR on an easement to create a parking area.

On the forestry side of things, our timber sale program continues to provide stable and consistent revenue to our department. Timber sale prices continue to be stable, and we have continued to market and sell attractive timber sales to our loggers. Continued progress on our carbon credit project is anticipated this year, with the inventory and verification process being completed. This will bring our project closer to issuance of credits, with potential for credit sales in early 2025. The revenue from these sales will be further evaluated for allocations, with several large tracts of land coming for sale within the county forest boundary. These parcels would be good candidates for acquisition when they become available.
