**Applicants must submit a SCALED drawing that shows the driveway location for the new residence or structure intersects with the road and an accurate measurement from the centerline of the new driveway to a property line, or an accurate measurement from the centerline of the new driveway to the centerline of a nearby intersecting road, or an accurate measurement from the centerline of the new driveway to the centerline of an existing driveway for a residence or structure that already has an address.** These measurements are explained in the illustration below. **Applicants may use an existing site plan that is available, or draw the location of the new driveway and new structures on an appropriate aerial photograph/parcel map** available in the Eau Claire County Department of Planning and Development or Beacon website

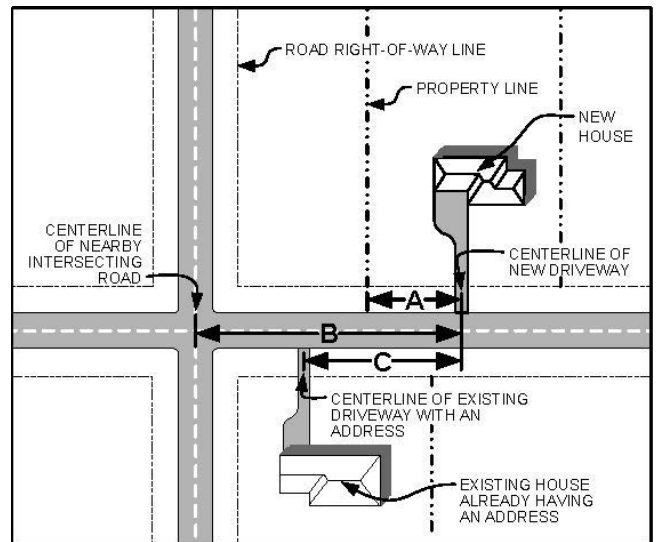

The drawing at right illustrates three types of measurements, any one of which is a measurement that can be used to assign a new address.

“A” is a measurement from the centerline of a new driveway to a property line on the property.

“B” is a measurement from the centerline of a new driveway to the centerline of a nearby intersecting road.

“C” is a measurement from the centerline of a new driveway to the centerline of the driveway of an existing residence or other structure that already has an address assigned.



**Each individual Municipality may have a Property Address Sign installation fee, please contact the Municipality to make arrangements. We no longer accept the fees for the Towns, Villages, and Cities.**

## APPLICATION REQUIRMENTS

- Site plan, must include location of driveway, structure, and accurate measurements (follow above instructions)
- Driveway Access Approval (from City, Town, County Highway, or State DOT)
- Floor Plans for multi-unit structures
