

Project Location

- Town of Otter Creek, Eau Claire County
 - County Road VV
 - (Between County Road V & County Road HH)
 - Bear Grass Creek Bridge







Purpose and Need of Project


- Purpose
 - Provide safe & efficient travel on County Road VV
- Need
 - Replace the existing bridge P-18-0082
 - Existing structure is in poor condition
 - Existing bridge is load posted at 30 tons





Project Funding

- Local Bridge Improvement Assistance Program
 - Project Eligibility
 - "Bridge" with clear span >20 feet
 - National Bridge Inventory (NBI) sufficiency rating <50
 - 100% Federal Funds (up to funding limit)
 - 100% Eau Claire County (over the funding limit)
- Trans 205 County Trunk Highway Standards
- Estimated Construction Cost
 - **■** \$500,000 **−** \$1,000,000







Project Schedule

- Final Plans Due: August 1, 2025
- Project Bid: January 13, 2026
- Construction: Summer 2026
 - No in-stream work between September 15 to May 15
- Construction Time: 2 3 months
 - CTH VV to be closed during construction







Existing Bear Grass Creek Bridge P-18-0082

- Single Span "T" Deck Girder Bridge with Total Length of 41.77-FT
- 28-FT Clear Roadway Width between Railing







Existing Bear Grass Creek Bridge P-18-0082

- Originally Constructed in 1924
 - Concrete Structure/Abutments
- Widened at some point
 - Timber Abutments
- Superstructure replaced in 1983
 - "T" Deck Girders
- Asphalt Overlay in 2008
- Steel drip edge installed in 2013







Preferred Bear Grass Creek Bridge B-18-0256

- Single Span Concrete Slab Bridge
 - 50.5-FT Total Length
 - 28-FT Clear Width
 - Solid Concrete Parapet




Elevation View







Plan View








County Highway VV

- Existing Roadway
 - 22-FT wide asphalt road
 - AADT = 160 vehicles/day
 - "Turn Down" Guardrail along roadway approaches
- Preferred Roadway
 - Replace asphalt 125-FT ± each side of new bridge.
 - Upgrade guardrail
 - Includes short-radius at driveway on SW corner








Right-of-Way Impacts

- 66-FT wide Existing Right-of-Way
- Permanent Limited Easement (PLE)
 - Required for short-radius installation and maintenance at driveway on SW corner
- Temporary Limited Easement (TLE)
 - Required for guardrail installation and grading new slopes







Public Fishing Easement

- Wisconsin Department of Natural Resources Public Fishing Easement
 - CTH VV Public Access will be restricted during construction
 - Please use CTH V to northwest to access fishing easement



 - OHE along South R/W

No Utility Conflicts are anticipated








Traffic Impacts

- Road will be Closed During Construction
- No Detour Route will be Posted
- Road Closed X Miles Ahead Signs
 - CTH HH (1.3 miles)
 - CTH V (0.1 miles)
- Access to all residences maintained
